SUBJECT: Resolution Authorizing the Establishment of Agency Bank Accounts at Rabobank

RECOMMENDATION: Adopt Resolution Authorizing RGS to open bank accounts at Rabobank for the deposit of Agency funds, payment of Agency expenses, and investment of idle cash.

FISCAL IMPACT

There will be a slight monthly cost for banking services. This cost is covered in the Agency's budget.

DISCUSSION & ANALYSIS

RGS Executive Director/CFO is being named as the Treasurer of the Agency. The Agency is hereby authorizing RGS to open a depositary bank account for deposit of Agency monies. This is a necessary first step for the Agency to be fully functional. The attached resolution authorizes the opening of these accounts and authorizes RGS to pay expenses therefrom.

BACKGROUND

The Agency will begin receiving revenues and start paying bills in September 2017. As such it needs to open a bank account. RGS currently banks at Rabobank. RGS recommends that the Agency open the following accounts:

- Checking account at Rabobank for Authority expenses and deposit of monies
- Investment account at Rabobank for investment of surplus funds

Once the Agency approves an Investment Policy, other investment vehicles can be used for investment of idle cash.
