### **Overview and GTAC Member Description**

The Salinas Valley Basin Groundwater Sustainability Agency (SVBGSA) staff is accepting applications from all interested organizations and individuals to join a Groundwater Technical Advisory Committee (GTAC) concerning groundwater related technical subjects.

The GTAC is limited to third party experts with expertise in hydrology, hydrogeology, hydrological modeling, civil engineering, or related field and is considered an ad hoc committee. The GTAC is convened at the recommendation of staff to provide technical input. Interested stakeholders may also retain and pay for a third-party expert to be a member participant of the GTAC. The Marina Coast Water District Groundwater Sustainability Agency, Monterey County Water Resources Agency, Monterey One Water, Seaside Basin Watermaster, Castroville Community Services District, Monterey Peninsula Water Management District, City of Salinas, Environmental Health Bureau and Arroyo Seco Groundwater Sustainability Agency may utilize in-house staff, or pay for a third-party expert for purposes of GTAC member participation. Each interested stakeholder or organization may submit an application for one member of the GTAC and one alternate member.
