#### **Overview and SMCTAC Member Description**

The Salinas Valley Basin Groundwater Sustainability Agency (SVBGSA) is accepting applications from all eligible and interested organizations and individuals to join the Sustainable Management Criteria Technical Advisory Committee (SMCTAC). The SMCTAC will review groundwater conditions and provide science based advice on management actions and projects to the Forebay Subbasin and Upper Valley Subbasin Committees.

The SMCTAC is limited to individuals with expertise in hydrology, hydrogeology, hydrological modeling, civil engineering, fisheries biology or related field. The initial objectives of the SMCTAC are to develop guiding principles, triggers and the decision making process to provide advice on management actions and projects. The SMCTAC is expected to meet annually to review the GSP Annual Reports for Forebay Subbasin and Upper Valley Subbasin and could be convened at other times as requested by the subbasin committees. All SMCTAC meetings are subject to the Brown Act.

Interested stakeholders may also retain a third-party expert to be a member participant of the SMCTAC. Agencies may utilize in-house staff, or retain a third-party expert for purposes of SMCTAC participation. Each individual or organization may submit an application for one member of the SMCTAC and one alternate member.
